## SUBCONTRACTING Trade Fair postponed to June 2021

Due to the current epidemiological situation in our region and the restrictions that came into force on October 17th, a total ban on activities related to the organization, promotion or management of events, such as fairs, exhibitions, conferences and events is in force on the territory of the Poznań district and the city of Poznań. The introduction of the so called red zone in the region is to protect against further spread of the COVID-19 virus. Unfortunately, at the same time, it makes it impossible to hold trade shows, including ITM Industry Europe, Modernlog, 3D Solutions, and Subcontracting, scheduled for 3-6 November 2020.

Following the decision of the central authorities, the board of Grupa MTP decided to postpone the fairs to 8-11 June 2021. At the same time, we would like to assure you that the time separating us from the next edition of the event will be used to create an even more valuable and attractive event. We want the next edition of the fair, which has been creating trends in the industry for years, to be unique and comfortable in every aspect, both for participants, exhibitors, organizers and everyone who is involved in creating such a unique event.

At the same time, we would like to inform that in connection with the entry into force of the new provisions of the Act of 2 March 2020 (Journal of Laws of 2020, item 374, as amended) referred to as the "anti-crisis shield", the deadline for reimbursement of funds paid by you has been extended to 180 days. Pursuant to Article 15(1) of the aforementioned Act, "An undertaking pursuing the activity related to the organisation of exhibitions and congresses or cultural, entertainment, recreational and sport activities or organising thematic exhibitions or open-air events, in the event of termination of a contract with a customer which is directly linked to the outbreak of the SARS-CoV-2 virus epidemic, is obliged to return the funds paid by the customer within 180 days from the date of effective termination of the contract."
